



Community Service Hours Form Pre and Post Approval

Toronto District Christian High School

- A student must complete a minimum of 40 community service hours after they have graduated from grade 8 as one of the requirements for the Ontario Secondary School Diploma (OSSD).
- The Ontario Ministry of Education and TDChristian High School agree that community involvement encourages “students to develop awareness and understanding of civic responsibility and of the role they can play and the contributions they can make in supporting and strengthening their communities (Ministry Policy/Program Memorandum No. 124a).”
- The focus for students at TDChristian is “learning for service in the light of God’s Word”. A primary way of serving God and others is to work for or with others as volunteers in the communities in which we live or to which we belong. We encourage students to volunteer gladly, often, and freely.
- Students along with their parent(s) or guardian(s) must plan their volunteering using the **Guidelines for Community Service Hours** to ensure that student’s volunteer hours qualify as community service hours. - Unless the community service hour event or activity is pre-approved (using this form), or, in the opinion of the principal, the activity or event qualifies for community service hours as outlined in the school’s **Guidelines for Community Service Hours**, TDChristian High School will not approve the hours. *The Ministry of Education gives the Principal the responsibility to make the final judgement using the guidelines.*
- Students who earn above and beyond the required 40 volunteer hours before graduation will earn a Minister’s Certificate of Recognition for Community Involvement (upon graduation). A bronze certificate for 50 - 99 hours, a silver one for 100 - 199 hours and a gold one for 200+. (Once students reach 200+ community service hours, TDChristian stops recording them).
